**QUESTIONS FOR ORAL ANSWER** 

- \*1. Mr. DAVID MARSHALL: To ask the Financial Secretary to give figures of the number of persons who have left the Colony without paying their Income Tax, and the total amount of Income Tax due by them, giving the break-down for each year since the coming into force of the Income Tax Ordinance.
- \*2. Mr. DAVID MARSHALL: To ask the Financial Secretary whether he has taken any action against these defaulters; in how many cases has action been taken; and for what amount.
- \*3. Mr. DAVID MARSHALL: To ask the Financial Secretary whether he will take measures analogous to those prevailing in almost all other territories to prevent the departure of residents until their Income Tax has been paid or a sufficient guarantee obtained for payment thereof.

- 1. Mr. JOHN EDE: To ask the Chief Secretary whether he will give details of the units and strength of (a) the military forces and (b) the Federation Police brought in to assist the Singapore Police Force during the recent riots.
- 2. Mr. JOHN EDE: To ask the Minister for Education whether he will supply details of the total cost of construction and equipping of each Government technical, secondary and primary school completed in the year 1956 to date, including figures showing cost of (a) purchase of land, (b) clearance of site, (c) construction of building, (d) provision of roads, playing grounds, drainage and fencing and (e) furniture and equipment; and whether he will give information regarding the economies made in construction of these schools compared with the schools completed in 1955.
- 3. Mr. JOHN EDE: To ask the Minister for Commerce and Industry whether he will supply details of the total catch of fish, prawns and crabs obtained in the two Government experimental prawn ponds for the period January -October 1956 and the sum realised therefrom; and whether it is anticipated that the catch for the year 1956 will exceed that for 1955.
