QUESTIONS FOR ORAL ANSWER

- *1. Mr. DAVID MARSHALL: To ask the Chief Minister when it is intended to publish the Report of the Committee on Minimum Standards of Living.
- *2. Mr. DAVID MARSHALL: To ask the Chief Minister when does the Government intend to give effect to the recommendations contained in the Second and Final Report of the Standing Orders Committee presented to the Assembly on 28th May, 1956, and contained in Sessional Paper No. L.A. 5 of 1956.
- *3. Mr. DAVID MARSHALL: To ask the Chief Secretary whether in the light of experience gained by the repeated delays in the elections for the City Council, he would consider establishing as of now, the machinery to prepare for General Elections for the Assembly next August, and whether he will give an assurance that adequate steps are being taken to make certain that there will be no question of postponement of such elections for reasons of lack of organisation.
- *4. Mr. DAVID MARSHALL: To ask the Chief Secretary—
 - (a) how many orders of banishment have been issued by the Governor in Council since 1st September, 1956; and
 - (b) how many of the persons in respect of whom such orders of banishment have been made came to Singapore when they were below the age of 10 and have been residing in Singapore ever since.
- *5. Mr. David Marshall: To ask the Chief Secretary—
 - (a) how many Orders for the arrest and detention or for the detention of persons under the Banishment Ordinance have been issued by him since the 1st of September, 1956; and
 - (b) whether he will make a statement as to the opportunities afforded to such persons at enquiries provided for by the Banishment Ordinance for learning of and meeting the allegations made against them.
- *6. Mr. David Marshall: To ask the Financial Secretary how many of the 1,344 private limited companies registered in Singapore made a profit exceeding 10 per cent of their paid-up capital in 1955, and the aggregate total of such excess profit.
- *7. Mr. David Marshall: To ask the Financial Secretary how many of the 127 public limited companies registered in Singapore made a profit in 1955 exceeding 10 per cent of their paid-up capital, and the aggregate total of such profits.
- *8. Mr. David Marshall: To ask the Financial Secretary whether the 10 per cent fee payable on first registration of any motor vehicle is payable by the purchaser of the motor vehicle or by the seller; and whether the receipts are issued on payment to the purchaser or to the seller.

- *9. Mr. LIM CHOON MONG: To ask the Minister for Communications and Works whether he will make a statement on the progress of the measures taken to relieve traffic congestion along that part of Yio Chu Kang Road between Serangoon Garden Way and Paya Lebar Post Office.
- *10. Mr. LIM CHOON MONG: To ask the Minister for Communications and Works whether he will take steps to ensure the safety of pedestrians at the 6th milestone, Yio Chu Kang Road, and to install a pedestrian crossing at that point.
- *11. Mr. Lee Choon Eng: To ask the Minister for Communications and Works whether any language qualification is necessary in order to obtain a driving licence.
- *12. Mr. John Ede: To ask the Minister for Communications and Works whether he will make a statement on the Government's policy regarding flood prevention, and in particular whether he will state the Government's intentions regarding the Ulu Pandan pilot scheme.
- *13. Mr. John Ede: To ask the Minister for Communications and Works if he will state the reasons why the 30 m.p.h. speed restriction continues to operate on long stretches of the dual carriageways of Bukit Timah Road.
