OUESTIONS FOR ORAL ANSWER

- *1. Mr. S. V. Lingam: To ask the Deputy Prime Minister whether he will give early consideration to (a) making Pesiaran Keliling a one-way street; (b) permitting the extension of bus services into the Macpherson Housing Estate; and (c) the parking of vehicles on one side only of Pesiaran Keliling.
- *2. Mr. P. Govindaswamy: To ask the Deputy Prime Minister whether arrangements will be made for the parking test of applicants for driving licences, carried out on the roadway in front of the new community centre under construction behind the Traffic Police Office at Maxwell Road, to be conducted at some other place when the community centre is completed.
- *3. Mr. S. V. Lingam: To ask the Deputy Prime Minister whether complaints made in the Tamil dailies about not using the Tamil language for the Highway Code Test for the issue of driving licences were brought to his attention, and whether he will appoint persons to conduct the Highway Code Test in Tamil also, as it is done in Malay, Mandarin and English.
- *4. Mr. S. Rajoo: To ask the Minister of Defence if he will consider the building of a community centre on the children's playground opposite No. 130 Race Course Road.
- *5. Mr. P. Govindaswamy: To ask the Minister for Health (a) how many beds there are in each hospital, giving separate figures for beds in the different classes, where applicable; (b) whether the number of beds in each type of hospital is adequate to meet present needs; (c) whether there is a programme for expansion of hospital bed accommodation to meet future needs, and if he will give details; and (d) if he will consider setting up an emergency unit at the Thomson Road Hospital for the treatment of casualties.
- *6. Inche Mohd. Ariff bin Suradi: To ask the Minister for Finance whether the Government will give house numbers to the houses built before 1st April, 1960, in Alsagoff Estate whose house owners are paying ground rent to the landlords or their agents.
- *7. Mr. S. V. Lingam: To ask the Minister for Culture and Social Affairs (a) who sponsored the recent shows by Hong Kong stars at the National Theatre; (b) what was the total collection; (c) what was the total expenditure; and (d) what was the net profit.

- *8. Mr. P. Govindaswamy: To ask the Minister for Law and National Development whether he is aware that the drainage in the kampong at Palmer Road is inadequate and if he will take steps to improve it.
- *9. Inche Mohd. Ariff bin Suradi: To ask the Minister for Law and National Development whether the Government will give first priority to requests for rural development projects, such as the improvement of roads, drainage, street-lighting and other public amenities for the Kampong Kembangan Constituency.
- *10. Inche Mohd Ariff bin Suradi: To ask the Minister for Law and National Development when will Jalan Senana, Jalan Lapang, Jalan Senyum and Jalan Selamat be made up.
- *11. Mr. R. A. Gonzales: To ask the Minister for Law and National Development what steps are being taken to ease the traffic congestion at the two pedestrian crossings near the Tampines Circus and whether any steps are being taken to construct an overhead bridge for pedestrians at this locality.

QUESTIONS FOR WRITTEN ANSWER

- 1. Mr. S. V. Lingam: To ask the Deputy Prime Minister whether he will consider revising the postage for local letters to the pre-Malaysia rate, i.e., ten cents.
- 2. Inche Mohd. Ariff bin Suradi: To ask the Minister for Education whether and when another primary school will be built at Kaki Bukit.
- 3. Inche Mohd. Ariff bin Suradi: To ask the Minister for Education whether non-Malay children, born in Singapore and adopted by Singapore-citizen Malays, are entitled to (i) free education from Primary to University level, and (ii) special Malay bursaries.
- 4. Mr. S. V. Lingam: To ask the Minister for Health (a) whether he is aware that the drains in Moonstone Lane, Opal Crescent, Ruby Lane, Topaz Road, Woodsville Road, Meyappa Chettiar Road and the surroundings are not cleaned properly and that the residents of those areas have complained about the breeding of mosquitoes, and whether the necessary action will be taken in the matter; and (b) whether he will cause the existing refuse bin centre at Meyappa Chettiar Road which is about ten feet away from the nearest houses to be removed.
