## QUESTIONS FOR ORAL ANSWER

- \*1. Mr. Teong Eng Siong: To ask the Minister for Education whether the Government has any plans to set up an Integrated School in the Sembawang Constituency for the enrolment of students in the English, Chinese, Malay and Tamil streams.
- \*2. Mr. Teong Eng Siong: To ask the Minister for Education whether the Government has any plans to set up a Technical School in the Sembawang Constituency.
- \*3. Mr. Teong Eng Siong: To ask the Minister for Education (i) the number of Malay Secondary Schools and the total number of students therein; and (ii) the number of Tamil Secondary Schools and the total number of students therein.
- \*4. Madam Chan Choy Siong: To ask the Minister for Health whether he is aware that in some clinics and dispensaries owned by doctors, the dispensing of poisons and dangerous drugs is carried out by unqualified personnel without the direct and personal supervision of the medical practitioner or qualified pharmacist, and whether he is contemplating steps to control the further employment of unqualified personnel in dispensing poisons and dangerous drugs.
