QUESTIONS FOR ORAL ANSWER

- *1. Mr. Ho See Beng: To ask the Deputy Prime Minister if he will consider permitting the entry into Singapore of non-Singapore citizens over the age of, say, 60 years whose sponsors can adequately provide for them.
- *2. Inche Rahamat bin Kenap: To ask the Minister of Defence, with the resumption of normal relations with Indonesia, whether steps will be taken to contact the owners of the premises of the Kebun Ubi Community Centre at Jalan Penggaga with a view to regularising the tenancy of the Centre and if improvements will be made to the premises, particularly to avoid flooding during heavy rains.
- *3. Madam Chan Choy Siong: To ask the Minister of Defence whether it is Government policy that women could and should also share in the task of safeguarding the security of our young Republic and whether he will take immediate steps to create more opportunities for them to serve in the Police Force.
- *4. Mr. Chow Chiok Hock: To ask the Minister for Foreign Affairs whether the Government intends to set up embassies or trade representations in East European Communist Countries.
- *5. Mr. Chow Chiok Hock: To ask the Minister for Foreign Affairs (a) to date, how many High Commissions and Embassies have been set up and in which countries; (b) how many personnel for diplomatic service have been recruited; and (c) what is the annual expenditure for High Commissions and Embassies.
- *6. Mr. Tay Boon Too: To ask the Minister for Education whether an integrated Secondary School and a Secondary Technical School will be built in the Paya Lebar Constituency.
- *7. Mr. P. Govindaswamy: To ask the Minister for Education what is the Government's financial contribution to the University of Singapore for 1966; and whether he will obtain and give a breakdown of how the contribution is expended.
- *8. Mr. S. Rajoo: To ask the Minister for Health whether he will consider the erection of a shed near the entrance of the Middleton Hospital to accommodate and give shelter to members of the public who visit patients in the Hospital.

- *9. Mr. Tay Boon Too: To ask the Minister for Health whether the Government is planning to establish an Outpatient Dispensary in the Paya Lebar Constituency.
- *10. Mr. P. Govindaswamy: To ask the Minister for Health whether the Government will build a market between the 4 m.s. and $7\frac{1}{2}$ m.s. Thomson Road, and when.
- *11. Madam Chan Choy Siong: To ask the Minister for Culture and Social Affairs whether he intends setting up an institute of research on problems of women, as outlined in "The Tasks Ahead, 1959", with a view to improving their social, economic and political status in society.
- *12. Mr. S. V. Lingam: To ask the Minister for Law and National Development whether he has received any requests from farmers of Kampong Potong Pasir and the surrounding areas for assistance to combat pests damaging their vegetables and what action has been taken in the matter.
- *13. Mr. S. Rajoo: To ask the Minister for Law and National Development whether the backlane behind houses Nos. 50 to 78 at Race Course Road will be made up, and when.
- *14. Mr. S. Rajoo: To ask the Minister for Law and National Development if he will consider setting up Government abattoirs in the Serangoon, Katong and Bukit Panjang Districts to facilitate the slaughter of pigs and other live-stock for the people of those areas for sale at rural markets.
