QUESTIONS FOR ORAL ANSWER

- *1. Mr. WILLIAM TAN: To ask the Minister for Labour and Welfare if he can give an assurance that all donations, whether in cash or in kind, sent to the Social Welfare Department, the Council of Social Service and various collection centres, in connection with the recent Kampong Tiong Bahru Fire, will be equitably distributed in full to all victims of the fire, and to state what steps will be taken to achieve this end.
- *2. Mr. LEE KUAN YEW: To ask the Chief Secretary whether a Malayan Officer who had been promoted to the post of Director of Special Branch as a result of Malayanisation has asked to retire on terms under the Retirement from the Public Service (Compensation) Ordinance, 1956, and on what grounds is the request made; and whether he will make a statement in the matter.
- *3. Mr. LEE KUAN YEW: To ask the Financial Secretary whether investigations regarding an account in the First National City Bank of New York in Singapore in which a very large sum of money was alleged to be under the control of a Minister were commenced by the Income Tax Department but subsequently stopped, and whether he will make a statement on the matter.
- *4. Mr. R. C. H. Lim: To ask the Minister for Education to state—
 - (a) the amount of money spent by the Government on vernacular schools in respect of (i) school buildings, and (ii) grants-in-aid, during each of the years from 1954 to 1958; and
 - (b) how many Chinese schools were given money by the Government in respect of (i) school buildings, and (ii) grants-in-aid, during each of the years from 1954 to 1958, and the amount of money granted in each case.
- *5. Mr. Lee Choon Eng: To ask the Minister for Communications and Works, in view of the different conditions under which licences to operate passenger transport services are granted to the Singapore Traction Company Limited under the Singapore Traction Ordinance and to other passenger-transport companies under the Omnibus Services Licensing Authority Ordinance, 1956, whether he will introduce amending legislation to apply uniform conditions of licensing.
