#### **QUESTIONS FOR ORAL ANSWER**

- \*1. Mr. Ho See Beng: To ask the Minister for Education if he has information of how many students of the Nanyang University and the Ngee Ann College are from West Malaysia, and how much financial aid is received by those two institutions from the Malaysian Government.
- \*2. Mr. Ho See Beng: To ask the Minister for Education if he has information (a) how many students in the University of Singapore are from West Malaysia, and how many Singapore students there are in the University of Malaya; and (b) how much financial aid is given by the Malaysian Government to the University of Singapore and by the Singapore Government to the University of Malaya.
- \*3. Mr. Ho See Beng: To ask the Minister for Finance if consideration will be given to appointing a Commission of Inquiry headed by a High Court Judge to inquire into the allegations by the Public Daily Rated Employees' Unions Federation about the implementation by Government of the 1961 Agreement, and, among other things, (i) to determine whether there has been delay in the implementation of the aforesaid Agreement and whether it has been fully implemented; (ii) to determine whether there had been adequate and competent handling of the dispute with, and the grievances of, the aforesaid Federation; and (iii) to recommend ways and means of settling all grievances within the context of a thorough re-organisation of public service departments, particularly the Cleansing Department of the Ministry of Health, with the view to increasing productivity and efficiency of the public services.
- \*4. Mr. Bernard Rodrigues: To ask the Minister of State (Prime Minister's Department) if he will consider (a) the installation of traffic lights at the junctions of (i) Kampong Bahru Road/Keppel Road/Telok Blangah Road and (ii) Nelson Road/Keppel Road; and (b) the establishment of zebra crossings at Telok Blangah Road (i) in front of Gate No. 10 and (ii) in front of the Kampong Jagoh Malay School.
