QUESTIONS FOR ORAL ANSWER

- *1. Mr. LEE KUAN YEW: To ask the Chief Secretary how many Malayan Officers appointed by the Secretary of State have applied to retire under section 18 of the Retirement from the Public Service (Compensation) Ordinance, 1956; whether he will state their names; and whether he will make a statement in the matter.
- *2. Mr. LEE CHOON ENG: To ask the Chief Secretary, on the termination of the Constitution Exposition at Kallang, whether the Government will make available a portion of the 200-acre site for the development of a sports stadium, and appoint a Board to collect funds for, and to administer, the stadium.
- *3. Mr. Lee Choon Eng: To ask the Minister for Local Government, Lands and Housing what is the policy of the Government in regard to the letting out of the Singapore Badminton Hall to applicants for professional purposes.
