QUESTIONS FOR ORAL ANSWER

- *1. Mr. G. A. P. SUTHERLAND: To ask the Chief Minister why the report of Dr. F. C. Benham, the Economic Adviser to the Chief Minister, of a survey conducted by him of the economic position of Singapore during 1956 which was reviewed in the local press on 28th June, 1957, was not in the first instance presented to the Legislative Assembly.
- *2. Mr. Lee Choon Eng: To ask the Chief Minister which of the Ministers and Assistant Ministers are provided with bodyguards; why are bodyguards necessary for them; the dates from which bodyguards were supplied to each Minister or Assistant Minister concerned; and the cost of these bodyguards to the public funds of the Colony.
- *3. Mr. Lee Kuan Yew: To ask the Chief Minister when the Government intends to Malayanise the post of Attorney-General.
- *4. Mr. LEE CHOON ENG: To ask the Minister for Labour and Welfare—
 - (a) whether he has taken steps to investigate the activities of private employment exchanges;
 - (b) whether he is aware of any complaints made to the Police against private employment exchanges; and
 - (c) whether he has taken or will take steps to protect the public from exploitation.
- *5. Mr. Lim Choon Mong: To ask the Minister for Labour and Welfare what benefit will Singapore derive from his participation in the recent I.L.O. conference.
- *6. Mr. Wong Foo Nam: To ask the Chief Secretary whether he is aware of the feeling of dissatisfaction among members of the Special Constabulary with their terms and conditions of service; and whether the Government is taking or will take steps to improve them.
- *7. Mr. GOH TONG LIANG: To ask the Chief Secretary—
 - (a) whether Government Land Bailiffs have been classified as clerks; and
 - (b) what are the duties of a Land Bailiff.

- *8. Mr. John Ede: To ask the Minister for Local Government, Lands and Housing whether he has taken or will take steps to implement the recommendations in paragraph 6 of the Second Report from the Public Accounts Committee (Sessional Paper No. L.A. 8 of 1957) in respect of the state of imbalance in the Land Office control accounts; and whether, in particular, the investigation team recommended in paragraph 6 (a) of the Report has been set up and is now at work.
- *9. Mr. Lee Choon Eng: To ask the Minister for Local Government, Lands and Housing if he will make a statement on the details of the system for the allocation of Singapore Improvement Trust accommodation.
- *10. Mr. Lee Choon Eng: To ask the Minister for Local Government, Lands and Housing if he is aware that the register of applications for Singapore Improvement Trust accommodation is not open for inspection by the public, and whether he will explain why.
- *11. Mr. R. Jumabhoy: To ask the Minister for Local Government, Lands and Housing, with reference to the Telok Ayer Electoral Division—
 - (a) whether any tenements or flats have been built by the Singapore Improvement Trust from April, 1955, to date;
 - (b) whether there is any scheme for slum clearance;
 - (c) whether any slum areas have been cleared from April, 1955, to date;
 - (d) what are the areas so cleared, giving the names of the streets or roads;
 - (e) how many dwellers in these slum areas were de-housed; and
 - (f) where have they been rehoused.
- *12. Mr. LIM CHOON MONG: To ask the Minister for Local Government, Lands and Housing whether Government will set up an all-party committee for delineation of the City Council electoral divisions.
- *13. Mr. Goh Tong Liang: To ask the Minister for Local Government, Lands and Housing whether he is aware that the people in rural areas have been and are suffering hardships from lack of water; and whether he will take steps to alleviate their hardships.
- *14. Mr. R. C. H. Lim: To ask the Minister for Local Government, Lands and Housing who are the members of the Nature Reserve Board.
- *15. Mr. John Ede: To ask the Minister for Communications and Works with reference to paragraph 10 of the White Paper (Sessional Paper No. Cmd. 48 of 1956), what progress has been made in the implementation of the various stages of the Government's policy of unifying the passenger transport system; what stages remain to be carried out; and on what dates will they be completed.
- *16. Mr. LEE KUAN YEW: To ask the Minister for Communications and Works how many men in the Airport P.W.D. Plant Section are being retrenched; and whether alternative employment could be made available.
- *17. Mr. John Ede: To ask the Minister for Commerce and Industry whether he has taken or will take steps to protect the growing pig and poultry production in Singapore by taking health measures to prevent the breeding of mosquitoes and flies in farming areas; and whether research is being undertaken to find suitable insecticides non-injurious to such farming.
- *18. Mr. Goh Tong Liang: To ask the Minister for Commerce and Industry whether permits will be issued to fishermen to do night fishing in the Straits of Johore.

- *19. Mr. R. C. H. Lim: To ask the Minister for Commerce and Industry—
 - (a) whether he has made any progress in his effort to obtain 1,300 acres of the Ulu Pandan Nature Reserve for prawn cultivation; and
 - (b) what is the view of the Nature Reserve Board on the release of the 1,300 acres of the Ulu Pandan Nature Reserve for prawn cultivation.

**4. The Minister for Local Government, Lands and Housing to move-

That this House is of the opinion that the terms of reference of the Commission of Inquiry on corrupt practices be extended so that inquiry can also be made into corrupt and improper practices by candidates for elections and their confederates, with a view to making recommendations as to how such malpractices can be effectively detected, punished and suppressed.
