# **QUESTIONS NOT FOR ORAL ANSWER**

- 1. Mr. John Ede: To ask the Chief Secretary, if he is aware that a very high porportion of the tickets sold in the Social Welfare lotteries organised in the Federation of Malaya by the Government Social Welfare Lotteries Board the proceeds from which are being used to finance Federation of Malaya Social Welfare projects are being bought by persons resident in the Colony of Singapore; and what steps the Minister proposes to take to remedy this situation.
- 2. Mr. R. Jumabhoy: To ask the Financial Secretary, if he will state the combined or respective hard currency earnings of Singapore and the Federation of Malaya for the years 1952, 1953 and 1954, what amount was allowed to be spent by Singapore importers, whether the Colony derives any direct benefit by handing its hard currency earnings to the United Kingdom, and whether such earnings are credited at the current market rate so that Singapore and the Federation can benefit thereby.

- 3. Mr. LIM CHOON MONG: To ask the Minister of Labour and Welfare, whether he is aware of the fact that the grant of \$5 per person to the victims of the storm which demolished their houses on 9th April, 1955, is causing severe hardship; and whether he will consider the question of assisting the victims to rebuild their houses.
- 4. Mr. John Ede: To ask the Minister of Labour and Welfare, if he will detail the Boys' Clubs situated in the constituency of Tanglin; how many Boys' Clubs are being organised within the constituency in 1955; and where they are to be sited.
- 5. Mr. John Ede: To ask the Minister of Labour and Welfare, if he will state the current figures of unemployment in the Colony.
- 6. Mr. Lim Choon Mong: To ask the Minister of Education, how many primary and secondary schools have been approved for construction during the year 1955; and how many of these schools are expected to be completed in 1955.
- 7. Mr. John Ede: To ask the Minister of Education, if he will detail the schools of all categories (i.e. Government, aided, private, etc., and whether primary or secondary) situated in the constituency of Tanglin; how many and what categories of Government schools are being built within the constituency in 1955; and where they are to be sited.
- 8. Mr. Goh Tong Liang: To ask the Minister of Local Government, Lands and Housing, whether he is aware that the Rural areas are very poorly supplied with electricity and water; and what steps does he propose to take to improve the supply of such services to these areas.
- 9. Mr. GOH TONG LIANG: To ask the Minister of Local Government, Lands and Housing, whether he will give particulars of the total acreage of Crown land in the Colony and how much of it is being occupied at present under temporary occupation licence.
- 10. Mr. LIM CHOON MONG: To ask the Minister of Local Government, Lands and Housing, how many housing units have been approved for construction during the year 1955; whether he will give particulars of the number of each type of housing unit so planned; and how many of these housing units are expected to be completed in 1955 in each category.
- 11. Mr. GOH TONG LIANG: To ask the Minister of Communications and Works, what steps does he propose to take to improve the roads and telephone communications in the rural areas.
- 12. Mr. Lim Choon Mong: To ask the Minister of Health, whether he will supply a list of the building projects planned for construction during the year 1955; and how many of these projects are expected to be completed in 1955.
- 13. Mr. JOHN EDE: To ask the Minister of Health, if he will detail the Government clinics and other medical buildings situated in the constituency of Tanglin; how many are being built within the constituency in 1955; and where they are to be sited.
