QUESTIONS FOR ORAL ANSWER

- *1. Madam Chan Choy Siong: To ask the Deputy Prime Minister whether it is proposed to re-demarcate the present boundaries of the fifty-one Constituencies as their present population ratios are quite disproportionate.
- *2. Mr. Bernard Rodrigues: To ask the Minister of Defence if he is aware that some employers deduct the pay of their workers who take time off for training in one of the military or para-military organisations; and whether and what steps he proposes to take to ensure that no employees suffer any loss merely by reason of their voluntary participation in such organisations.
- *3. Madam Chan Choy Siong: To ask the Minister of Defence whether he is aware that the present uniforms of both the Police Force and the Armed Forces still carry the emblem of the British Crown, a symbol of the colonial era, and whether he has any plans to cease the use of the emblem.
- *4. Mr. Ho Kah Leong: To ask the Minister for Education if he will consider introducing agricultural science as a subject in secondary schools in rural areas.
- *5. Madam Chan Choy Siong: To ask the Minister for Health whether he is aware that the health environment of Covent Garden in the Delta Constituency has been poor and what measures he proposes to take to improve it.

- *6. Mr. Tang See Chim: To ask the Minister for Health if he will make a statement as to why the surgical facilities of the General Hospital were withdrawn from Professor Tinckler.
- *7. Mr. P. Govindaswamy: To ask the Minister for Finance the number of soap factories operating in Singapore; whether the production of soap is sufficient to meet local needs and whether the prices of locally-produced soap have risen with the increase in prices, because of import duties, of imported soap.
- *8. Mr. Teong Eng Siong: To ask the Minister for Finance what is the reaction from local and foreign industrialists to the incentives for export and investment granted by the Government from 1st January, 1967.
- *9. Mr. Teong Eng Siong: To ask the Minister for Finance what is the response from private developers to the proposed reduction in the rate of property tax on properties erected in areas designated for urban redevelopment.
- *10. Mr. Bernard Rodrigues: To ask the Minister for Labour if it is the intention of the Government to maintain the existing minimum two years residential qualification for alien wives of Singapore Citizens for registration as Singapore Citizens and whether similar provision will be extended to alien husbands of Singapore Citizens.
- *11. Mr. P. Govindaswamy: To ask the Minister for Labour if he will state, by races, the number of applications received from adults for Singapore Citizenship, and the number approved, in 1965, and the number of minors registered as Singapore Citizens in the same year.
- *12. Mr. Ho Kah Leong: To ask the Minister for Law and National Development whether he will consider setting up a fisheries co-operative to assist fishermen in Singapore.
- *13. Mr. Ho Kah Leong: To ask the Minister for Law and National Development whether he is aware of complaints by farmers of the poor nutritive content of certain feed-stuffs for animals sold in Singapore, and what measures will be taken to stop the sale of such feed-stuffs.
