And provided also that the provisions of this section shall apply in respect of the alterations in the electoral divisions of the City from those existing under the Municipal Elections Ordinance, 1948:

And provided also that the provisions of this section shall apply in respect of the new electoral divisions of the District Councils.".—(Mr. John Ede).
