Mr. John Ede: To ask the Minister for Local Government, Lands and Housing whether he is aware that the Singapore Improvement Trust has planned the completion (a) of less housing units in 1956 than were completed in 1955 and (b) of a lower percentage of housing units carrying rentals of not more than \$30 p.m.; and whether this represents the Government's policy in the matter.

- (2) Part XVIII: Add: "142... Saving of City Council's Rights." Subject to the Bill passing the Committee stage the Minister for Local Government, Lands and Housing will move its Third Reading.
