QUESTIONS FOR ORAL ANSWER

- *1. Mrs. Devan Nair: To ask the Minister of Defence when construction of the proposed Community Centre for Moulmein will commence and the estimated date for its completion.
- *2. Mrs. Devan Nair: To ask the Minister of Defence if he will consider a relaxation of paragraph 4 of the Schedule to the Immigration (Prohibition of Entry) Order, 1966, to allow wives of Singapore Citizens to enter the Republic though they may have been living separately from their husbands for more than five years.
- *3. Mr. S. V. Lingam: To ask the Minister for Culture and Social Affairs if he is aware of complaints about the poor quality of reception on the wavelength over which Tamil programmes are now broadcast by Radio Singapura; and, whether he will take steps to have this wavelength altered.
- *4. Mr. S. Rajoo: To ask the Minister for Law and National Development, in view of the recent floods in the Cambridge Road, Owen Road and Norfolk Road areas, (a) if he will consider taking immediate steps, as a temporary measure, to raise the embankment and widen the canal between Keng Lee Road and the Kandang Kerbau Police Station; and (b) whether he will consider requesting the Housing and Development Board to give priority in the allocation of the Board's flats to applicants from these areas who wish to move out.
- *5. Mrs. Devan Nair: To ask the Minister for Law and National Development if he will request the Housing and Development Board to permit a choice of locality when they offer flats to applicants who have been given notice to quit State land.
