QUESTIONS FOR ORAL ANSWER

- *1. Dr Ong Seh Hong: To ask the Minister for National Development, if the Lift Upgrading Programme (LUP)'s main objective is to provide barrier free access to all residents in light of our aging population, will his Ministry consider (a) extending the Programme to all HDB blocks without the need to vote; (b) if voting is insisted upon, setting it at a simple majority rather than the current "YES" vote of 75%; and (c) if the 75% "YES" vote is insisted upon, conducting a re-poll of those blocks with lower than 75% as this may not have been reached not because of "NO" votes but because some residents have not voted.
- *2. Mr Yeo Guat Kwang: To ask the Minister for Manpower (a) whether labour suppliers who have been permitted to bring in foreign workers for one job can be permitted to deploy them for another; (b) if deployment is not permitted, how many such breaches have his Ministry dealt with in the past three years; and (c) are there plans to step up enforcement actions against such breaches.
- *3. Mr Yeo Guat Kwang: To ask the Minister for Manpower (a) how does his Ministry ensure that employers provide decent and reasonable living conditions for their foreign workers and (b) in the past three years how many cases of employers, who failed to provide the required accommodation, have been investigated and dealt with.
