6. The Deputy Prime Minister to move—

That this Assembly orders that the Commissioner of Police do take care that during the present session of this House the passages through the streets leading to this House be kept free and open, and that no obstruction be permitted to hinder the passage of Members to and from this House, and that no disorder be allowed in the passages leading to this House, and that there be no annoyance therein and thereabouts; and that the Clerk of this Assembly do communicate this order to the Commissioner aforesaid.

7. The Minister for Labour and Law to move—

That this Assembly, pursuant to subsection (7) of section 30 of the Singapore (Constitution) Order in Council, 1958, resolves that the remuneration of the State Advocate-General shall be \$2,075 a month.

8. The Deputy Prime Minister to move-

That this Assembly, pursuant to subsection (3) of section 37 of the Singapore (Constitution) Order in Council, 1958, resolves that the allowance of the Deputy Speaker shall be \$500 a month.

"We, the Legislative Assembly of the State of Singapore, express our thanks to the Yang di-Pertuan Negara for the speech which he delivered on behalf of the Government at the opening of the present session of this Assembly.".

'but regret that the speech did not in principle clarify the special position of the Malays who are recognised as the indigenous people of the Island of Singapore'."
