That this Assembly, pursuant to subsection (1) of section 79 of the Singapore (Constitution) Order in Council, 1958, resolves that the remuneration of the Chairman and Members of the Public Service Commission established under section 76 of the aforementioned Order shall be as follows:—

- (a) for the Chairman, an inclusive salary of \$2,000 per month;
- (b) for the Deputy Chairman, a retainer of \$750 per month, and, in addition, \$30 per day on which he attends a meeting of the Commission with a maximum of 20 days in any one month; and
- (c) for other Members, a retainer of \$500 per month, and, in addition, \$30 per day on which they attend a meeting of the Commission with a maximum of 20 days in any one month.
