QUESTIONS FOR ORAL ANSWER

- *1. **Dr Intan Azura Mokhtar:** To ask the Minister for Education whether Temasek Polytechnic and Ngee Ann Polytechnic had carried out any due diligence to check the background and academic qualifications of Mikhy Farrera-Brochez who apparently had the qualifications of APA, APS, MCollT, MS DPSY, DipED and who was later convicted of having forged his educational qualifications, before employing him.
- *2. **Dr Intan Azura Mokhtar:** To ask the Minister for Health whether there are stricter measures put in place to ensure blood tests cannot be forged for employment purposes.
- *3. **Mr Louis Ng Kok Kwang:** To ask the Minister for Health whether the Ministry will consider issuing guidelines on disability duration for specific injuries for the use of doctors issuing medical leave and light duties for injured workers returning to work.
- *4. **Assoc Prof Walter Theseira:** To ask the Minister for Foreign Affairs (a) whether the Malaysian Government's detention of Greek vessel Piraes and crew, which collided with the Malaysian vessel Polaris in Singapore territorial waters, represents an exercise of foreign sovereignty in Singapore territorial waters; and (b) what measures can be taken to ensure that vessels, crew and passengers, particularly Singapore-flagged, will not be subject to foreign authority whilst in Singapore territorial waters or for acts committed in Singapore territorial waters.
- *5. **Mr Louis Ng Kok Kwang:** To ask the Minister for Home Affairs (a) what are the findings from the trial of using speed-tracking devices for heavy vehicles in 2018; and (b) whether there are plans to mandate speed-tracking devices for heavy vehicles to curb speeding.
