QUESTIONS FOR ORAL ANSWER

- *1. Mr. LEE KUAN YEW: To ask the Chief Secretary whether the jurisdiction over the whole building of this House of Assembly has been vested in Mr. Speaker.
 - *2. Mr. M. P. D. NAIR: To ask the Chief Secretary if he will state the number of detainees detained under the Emergency Regulations who have been transferred to Detention Camp in Ipoh as at 15th of July, 1955; why such transfer is necessary; and what facilities are afforded for their wives or parents in Singapore to visit them in Ipoh.
 - *3. Mr. LIM CHOON MONG: To ask the Chief Secretary if he will state the number of applications from locally qualified doctors received for general duty posts since 1954; and the number of appointments made.
 - *4. Mr. LEE KUAN YEW: To ask the Attorney-General when he proposes to complete the revised edition of the Laws of Singapore.
 - *5. Mr. SEAH PENG CHUAN: To ask the Minister for Communications and Works if he is aware that there is no Post Office in the Kampong Kapor Division; and whether he will consider establishing one there in the near future.
 - *6. Mr. JOHN EDE: To ask the Minister for Communications and Works whether the special officer appointed to investigate into the causes of flooding throughout the island and to recommend measures of prevention has submitted his report, and what the Government's intentions are in this matter.

Clause 2, page 2, after line 7: Insert after the definition of “Contract of service” a new definition “‘contractor’ means any person who contracts with a principal to carry out the whole or any part of any work undertaken by the principal in the course of or for the purposes of the principal’s trade or business;”.

Provided that in the circumstances mentioned in this subsection no employer shall be liable to pay such allowance in respect of a period exceeding thirty days.

(2) If a female workman dies from any cause on or after the day of her confinement and before any maternity allowance to which she is entitled has been paid to her the employer shall pay to the person nominated by her under section 102 of this Ordinance or, if there is no such person, to her legal representative, any maternity allowance to which she is on the day of her death entitled in respect of the period up to the day of confinement and in respect of the period after confinement up to the day preceding the day of her death".

(2) The powers of the Commissioner under subsection (1) of this section shall include the power to hear and decide, in accordance with the procedure laid down in this Part, any claim by a sub-contractor for labour against a contractor or sub-contractor for any sum which the sub-contractor for labour claims to be due to him in respect of any labour provided by him under his contract with the contractor or sub-contractor and to make such consequential orders as may be necessary to give effect to his decision."

1. Mr. M. P. D. NAIR: To ask the Minister for Commerce and Industry whether the Government has considered the Report of the Local Produce Working Committee dated 2nd June, 1951; and whether action is contemplated to implement any of its recommendations.
2. Mr. M. P. D. NAIR: To ask the Minister for Commerce and Industry whether he will give details of the Government's plans for the provision of Veterinary and Animal Husbandry Services in the rural areas during the year 1955.
3. Mr. LIM CHOON MONG: To ask the Minister for Commerce and Industry whether it is still the policy of Government to maintain a stockpile of rice and to sell it on a non-profit basis to the people.
4. Mr. LIM CHOON MONG: To ask the Minister for Commerce and Industry if he will state—
 - (a) the cost of rice per ton as purchased by the Government;
 - (b) the selling price per ton from the stockpile;
