NOTICES OF AMENDMENTS TO BILLS

In Committee

✓ **Light Dues (Amendment) Bill** [Bill No. 152]

Clause 3:

Minister for Commerce and Industry:

In page 2, lines 14 and 15: to leave out "repairing or because of damage" and insert "emergency repairs in respect of damage occasioned on the high seas".

✓ **Malayan Royal Naval Volunteer Reserve (Amendment) Bill** [Bill No. 141]

Clause 8:

Chief Secretary:

In page 3, line 14: after "wounds", to insert "or injuries".

New Clause:

Immediately after Clause 6:

'Amendment of section 16. 7. Section 16 of the principal Ordinance is hereby amended—

- (a) by deleting the sign brackets and figure "(1)" occurring in the first line thereof;
- (b) by inserting the word "male" immediately after the word "Every" occurring in the first line thereof; and
- (c) by deleting the existing subsection (2) thereof.'
