- 3 Economic Expansion Incentives (Relief from Income Tax) (Amendment) Bill – "to amend the Economic Expansion Incentives (Relief from Income Tax) Act 1967" – President's recommendation signified and Bill presented by the Minister of State (Mr Alvin Tan), on behalf of the Deputy Prime Minister and Minister for Trade and Industry; read the first time; to be read a second time on the next available sitting day and to be printed.
